Dale brought up discussion on revisiting the need for our West End Area virtual meeting every Saturday from 7:00pm-8:30pm. The meeting is struggling for support and not well attended. The question is do we need to continue the meeting, we are paying \$65.00, is it necessary. We also have had to address groups' concerns about how much money is in the AREA acct. and how we disburse. Our answer has always been that we are in unprecedented times managing and forecasting future needs of our groups after the pandemic had us be watchful over our disbursements of funds. Dale wants to thank GSR and Area committee members for allowing him to serve. Kelvin announced he is officially the new GSR for "Keeping the faith". Lateef mentioned that we should look at revisiting the budget and if needed increase committee expenses and prudent reserves in order to have a clear budget and disburse the rest .Dianna B. also discussed increasing committee budgets or put a motion to hold money in the account pending on what will happen with this pandemic. This can be done without changing budgets. Also in policy the quorum is 15 GSR in order to be able to vote, the policy is specific and we should stand by it.

Lateef reminded Dianna that we voted on revising the way we look at quorum due to our low turnout of GSR on our virtual AREA meetings, furthermore this revision was in effect to allow the voting in of vice chair, Literature chair and alt treasurer positions. Dianna also sent the secretary a draft copy of policy to be sent to our web facilitator to post on our website. Donald C privately messaged me to add to Open Forum that we should document and share our experiences on how we conducted business and kept the West End Area functioning in the current pandemic.
